- 1. The three second rule pertains to when the offensive team has control in either their front or backcourt. T or F
- 2. To establish a position outside the three-second lane, the player must place both feet on the playing court outside the lane. T or F
- 3. The three second rule is NOT in effect when a team is in control of the ball for a throw-in. T or F
- **4.** The ball is at the disposal of free thrower A3. B1 steps into the lane, and the official gives the delayed-violation signal. A1 then requests a timeout. When the team returns to the free throw after the timeout, the official puts the ball at the disposal of A3 and again gives the delayed-violation signal. The free throw is missed by A3, and the official awards a substitute free throw. T or F
- **5.** Team B sets a double screen for B1, who leaves the playing court voluntarily and runs under the basket, circles around, returns to the playing court, and then is the first to receive the ball. The official calls a violation on B1. T or F
- **6.** The alternating-possession procedure starts when an official places the ball at the disposal of a player for a throw-in. The alternating-possession procedure ends, and the arrow is reversed immediately when a passed ball legally touches a player inbounds. T or F
- 7. The alternating-possession procedure starts when an official places the ball at the disposal of a player for a throw-in. The alternating-possession procedure ends, and the arrow is reversed immediately when a player, who is located on the playing court, touches, and causes the ball to be out of bounds. T or F

- **12.** Prior to the start of the game the official checking the book at the 11-minute mark notices #68 and #17 listed in the scorebook for team B. The official assesses an Administrative Technical foul. T or F
- **13.** After the ball is placed at the disposal of a free-thrower, it is a violation when the free-thrower purposely fakes a try or the free-thrower's teammates or opponents purposely fake. T or F
- **14.** On a free throw by A1, B1 commits a lane violation. Following the lane violation by B1, A1's free throw misses the ring and flange? The official calls a violation of B1. T or F
- **15.** A1's pass is kicked by B1, the shot clock reads 12 seconds. The official has the shot clock operator reset to 15 seconds. T or F
- **16.** A1 is attempting her second of two free throws when B1 commits a lane violation. Following B1's lane violation, A2 who is located above the free throw line and behind the three-point line, steps inside the three-point line before the ball hits the ring or flange. This is a double violation. T or F
- **17.** An inadvertent whistle occurs any time an official blows the whistle by mistake and does not have a ruling to make. T or F
- **18.** A1 passes the ball to A2, while the pass is in flight, the trail official has an inadvertent whistle. The official uses the point of interruption to put the ball back into play. T or F
- **19.** Team A has been given a warning in the first quarter for "flopping". In the 4th quarter B4 is dribbling down the sideline in the backcourt, A5 is in legal guarding position and well before contact falls backward onto the ground. The official immediately calls a Team Technical foul for "Faking Being Fouled". T or F
- **20.** A5's try is in flight; the trail official has an inadvertent whistle. The try is successful, Team B will receive the ball on the end line and is entitled to run the end line. T or F

- **21.** A4's pass is deflected by B4, the pass is loose, the lead official has an inadvertent whistle, the official uses the alternating possession arrow to put the ball back into play. T or F
- **22.** The Referee shall inform each team and the table officials regarding the overtime procedure when the score is tied at the end of regulation. T or F
- 23. When calling a foul the official shall stop the clock with a fist in the air. T or F
- 24. The Referee shall decide matters upon which the timers and scorers disagree. T or F
- **25.** A4 fouls B4, team B is not in the bonus, the official errors by awarding B4 two free throws. B4's first free throw is successful; the error is then discovered. The official counts the free throw and then gives the ball to Team A on the endline for a throw in. T or F
- **26.** A5 drives to the basket for a layup, she is fouled by B5. The try is successful. A1 erroneously attempts the free throw. While A1's free throw is in flight, B4 fouls A4. The official recognizes the error. The official cancels the free throw. T or F
- **27.** B1 is fouled by A1 on a successful 2-point attempt. B2 is erroneously awarded the free throw. While B2's free throw is in flight, A4 is assessed an *intentional foul* on B3. The official recognizes the error. The official should cancel the foul. T or F
- 28. The Referee will correct all errors and mistakes within the prescribed time frame. T or F
- **29.** The Referee shall forfeit the game when the conditions warrant. T or F
- **30.** A1 fouls B1 on an unsuccessful shot attempt. B1 misses the first free throw, and the official allows the ball to remain live on the rebound. B4 passes the ball to B5 who scores a lay-up. A3 takes the ball out of bounds and throws the ball to A4 who is dribbling up the floor. The trail official realizes that B1 did not receive her second free throw. B1 will shoot one free throw and play will continue with the result of the free throw. T or F
- **31.** B4 holds cutter A4. The official reports the foul and is not notified that Team A is in the bonus. Thrower-In A1 throws the ball to A3 who scores. The official now realizes that A4 should have been awarded 2 free throws. The official awards A4 her 2 free throws and play will resume as after any normal free throw. T or F
- **32.** Team Technical Fouls are two free throws awarded to any player of the offended team followed by a throw-in at the division line opposite the scorers' table. T or F
- 33. A1 is dribbling the ball in the back court and there are 25 seconds on the shot clock. B3 and A3 commit a double foul in the front court. Team A will receive the ball at the point of interruption and the "10" second count will reset. Tor F
- **34.** A1 is dribbling the ball in the back court and there are 22 seconds on the shot clock. The coach from team "A" calls a timeout so they can reset the "10" second count. Team A will receive a new "10" second count. To r F
- **35.** A1's try strikes the ring and is unsuccessful. The ball is batted into the back court where A4 recovers the rebound. The shot clock operator reset the shot clock to 20 seconds. T or F
- **36.** The referee must toss the jump ball. T or F
